Subject: **CLEARANCE / RE-SUBMISSION OF DEFICIENT DOCUMENTS**

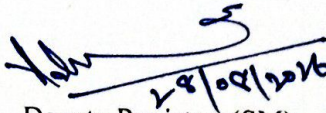
