- 3. The first-semester fee & dues challans have been uploaded on **eportal.iub.edu.pk** of each selected candidate. The candidates are advised to download their fee& dues challan from their portals. Those who do not submit the paid challan and document files by 19-04-2024, at the University College of Nursing will lose their right



to admission and cannot claim their candidature after the due date. The vacant seats will be filled from the waiting list.
