1. The order in which the candidates are seated will be forwarded to the Examiner Should a candidate be discovered to have copied from another. He/She will be externed from the Examination as well the candidate from whom, he/she copied if their a reason to suppose that the copying was convicted at by the later and as such an unfair menas case will be registered against his/her and he/she will be dealt with accordingly under the Regulation.

Any candidate detected to have in his/her possession in he Examination Hall during the Examination, any type of objectionable material, an unfair means case will be registered against him/her leading to disqualification

from the examination for the period as the case may be.

3. No candidate wihout, special permission of the officer in-charge shall leave his/her seat of the examination room till the end of the Examination. No candidate shall speak without stand up in his/her place and the officer in charge will see to his/her wants.

Before beginning his/her answer, each candidate shall write on the title page of his/her answer book the following viz the examination the subject the number of the paper his/her of the Roll No. and date, when the time allowed has expired the answer book must be delivered to the superintendent, even though the candidate may not have answered any part of the paper.

INSTRUCTIONS FOR FILLING IN IMPOTANT COLUMNS IN THE ADMISSION FORM

Quote Admission form No permanent district shown in the admission form subject, offered by him, name of center. University Fee receipt No. and Father's Name in all correspondence before the receipt of Roll No. Afterward, Roll No. will be your reference Number.

Any correction made in the form must be initiated by the candidate or by the officer attesting the form.Column (Religion) - State whether Muslim, Hindu, Jain, Buddist, Parsi, Christian or other, the superfluous wards should be added.

Column No.3:- (Center at which to be examined) every candidate must write the place of examination center which is nearest to place where has been studying at which he must appear if, however under exceptional circumstances, a candidate intends to appear at another center he/she must submit an application on a prescribed form to this effect duly adequate by the Controller of Examination he/she will be allowed to appear at that Center. A candidate of Examination (first paper) to be sure of his/her Examination Hall.

GENERAL RULES FOR GUIDANCE OF CANDIDATES

1. Change of Examination Center:- A candidate seeking change of the Examination Center after the submission of admission form should apply on a prescribed form which can be had form this office on the application. This should be admitted through the officer attesting the admission form. He/She should also deposit through Habib Bank Ltd. Challan a fee of Rs. 2000/- for change of centre.

Examination Center of the late fee candidate: In case candidate submitting the admission form with late fee, he University reserves the right of allotting any centre to such candidates other then that asked for by them in

their admission forms

Fee for a duplicate copy of Roll Number:- A candidate who has lost his/her Roll Number slip before the commencement of Examination, can apply for a duplicate copy of the same through a well-know officer, fee for a duplicate copy for the Roll Number is Rs.200/-only

Refund of fee:-Admission fee once paid shall not be refunded unless the candidate is declared ineligible and his admission to the Examination has been refused by the University office or the candidate dies before the commencement of examination. The examination fee can not be kept credit for any subsequent examination under any circumstances.

All applications for refund of fee should be made after the result of Examination has been declared on a prescribed form obtainable from this office on an application. The candidate must given reference of all office letter/memo, under which admission is refused and should also state the University fee receipt number. Claim for refund of fees shall be entertained only if it made within one year from the date of commencement of the Examination concerned.

5. Dispatch of Roll Number:- Roll Number to candidates will be sent by post at least 10 days before the commencement of the Examination. If however, a candidate does not receive his/her Roll No. 7 days before the commencement of the examination. He/She should at once send a registered letter giving the reference of his University fee receipt number permanent district shown in the admission form, the admission form number, subject offered name of center and father's name should also be stated.

Intimation of Result:-Every candidate will be informed of his/her result wihin 15 days after the declaration of the result on the address given by him/her for dispatch of result card. Any change in address must be communicated to this office not later than 15 days of the commencement of the Examination, so that intimation regarding result may, not go astray. Telegraphic intimation regarding results is to communicated by the office Duplicate result card

be had on payment of Rs.500/- only

7. Revision of answer books etc:- The Controller of Examination may on receipt of an application on the prescribed form accompanied by a fee of Rs.800/- per subject satisfy himself in regard to marking to answer book of completion of the result of candidate. Such application would be entertained only within 40 days from the date of declaration of the result. The office will dispose them off within 15 days from the date of their receipt, if however, fee of Rs.1600/- (Double fee) per subject is paid, the application would be disosed off within 96 hours of their receipt.

Note:- Registered No. of Board of Intermediate Secondary Education or of any other University is not accepted under the rules.
